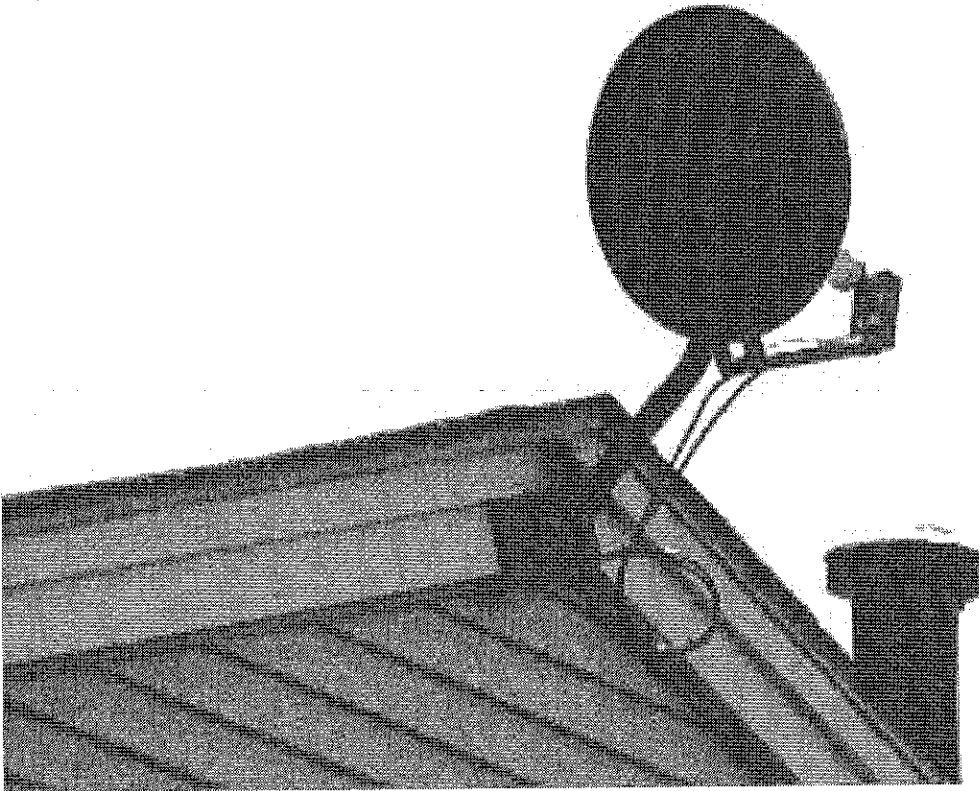


## SATELLITE TV ANTENNA INSTALLATION SPECIFICATION

1. THE MANAGEMENT COMPANY INSPECTOR MUST APPROVE ALL INSTALLATIONS. A **SATELLITE TV PERMIT REQUEST MUST BE COMPLETED BY THE REQUESTOR AND APPROVED BY THE INSPECTOR BEFORE INSTALLATION CAN START.** The permit fee must accompany the permit request.
  2. Satellite TV antenna's must be installed in one of the following locations.
  3. Attached to the **FACIA** as indicated in **PICTURE 1 Recommended or preferred installation.**
  4. Attached to the deck post as indicated in **PICTURE 2**
- After each picture you will see install instructions and restrictions.



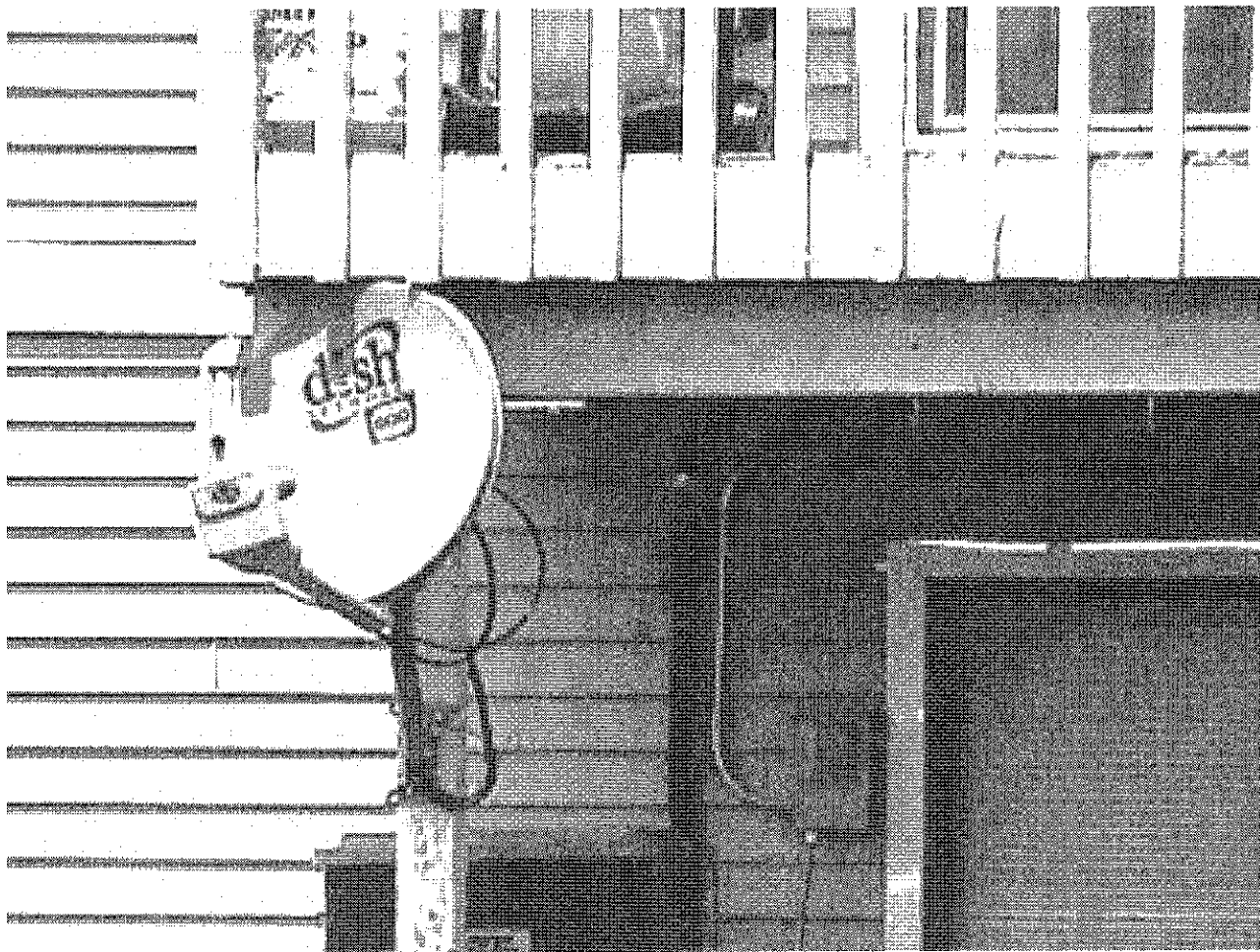
**PICTURE 1**

### **Picture 1 is the preferred**

The installation must be as indicated in picture 1 above. The SATELLITE TV ANTENNA is mounted to the FACIA and the cable must go into the attic of the house directly below the antenna as indicated in Picture 1.

1-cable can run down fascia to gutter, cable then will be required to run in the gutter to the corner section of siding, at this point the cable can be tucked under corner section of siding so not to be visible and run down to the bottom section of siding to attach directly to cable box so to feed complete home.

2- Any siding, fascia or other damage will be the home owners responsibly to repair or replace.



**PICTURE 2**

Picture number 2 above is the alternative for mounting a DISH.

In this case the DISH is mounted on a deck post. The cables must be connected to the underside of the deck and go directly into the basement just below the Deck Ledger board. An alternative could be to run the cables down the back of the deck post into the ground – underground to an existing cable box.

In all cases the entry point of the cables must be sealed with appropriate caulk

All cables must go directly into the house. If you wish multiple installations the cable must be run **INSIDE** the house. **NO CABLES ARE ALLOWED TO BE RUN ON THE OUTSIDE OF THE HOUSE AND CABLES CANNOT BE ATTACHED TO THE SIDING. SPLITTERS MUST BE ON THE INSIDE OF THE HOUSE.**

All installations must be inspected by an inspector designated by the board. Any problems with the installation must be corrected within 10 days or the board reserves the right to have corrections made at the homeowner's expense.

### PICTURE 3

**Picture number 3 above is the alternative for mounting a DISH.**

**In this case the DISH is mounted on a ground post. The cables must be buried in the ground from the post to the house and then connected inside the cable TV box.**

All cables must go directly into the house. If you wish multiple installations the cable must be run **INSIDE** the house. **NO CABLES ARE ALLOWED TO BE RUN ON THE OUTSIDE OF THE HOUSE AND CABLES CANNOT BE ATTACHED TO THE SIDING. SPLITTERS MUST BE ON THE INSIDE OF THE HOUSE.**

All installations must be inspected by an inspector designated by the board. Any problems with the installation must be corrected within 10 days or the board reserves the right to have corrections made at the homeowner's expense.
